News from our Coordinator

Dear Branch Chairs,

It's Convention time already and CM Council is very busy preparing recitals, training sessions and more. Please be sure to review the training calendar and take special note of the branch chair meeting Saturday at 9:00-10:30 a.m. CM Branch Chair/All Instrument Chairs, attendance is required or please send a representative.

Now is the time of year when CM Chair transitions begin to happen. The CM Council would like to know as soon as possible when someone new is stepping into the position. The Branch President and outgoing Branch Chair should notify the CM Council Liaison (Evaluator Training Chairs North/South) with the name of the new chair. They will tell you the procedures for updating information in the database and more.

As announced in the State Board MTAC Newsletter May issue, a Parent/Adult Consent Waiver must be signed "on-line" for participation in all State programs. The consent/waiver form is required and is similar to what parents already sign for their children for school or sports activities. A special computer lab will be available for your Branch representative to have special "hands on" training. Both Mac and PC computers will be available.

We recommend that you send a Branch Rep to one of the sessions, we're all new with this, but hopefully it will only take a few minutes to practice the procedure. Please send someone from your Branch to "drop in" during one of the 45 minutes sessions.

Another important announcement from the State Board is the elimination of Path B. A few chairs have sent me their feedback both negative and positive. Included in this letter is the input from the MTAC Newsletter and CM Council's info to help Chairs and teachers with this transition. We will only be referring to "Certificate of Merit," the term "path" will be removed from our policies and other documents. Also, at the end this newsletter you'll see the reasons and importance of why Path B was removed from our program.

Be sure to purchase your Piano and String Syllabi during Convention for the special convention discount.

My sincere thanks to each of you and your committees for all the work you do for CM. Please remember to forward this newsletter to your members.

Certificate of Merit, Path B

In the March issue of the MTAC News, I spoke to you regarding our intellectual property and the need to protect our State Programs. The State Board appointed a special committee to gather information and advisement from State Chairs, Certificate of Merit Council, MTAC State Office personnel, and outside experts regarding the best ways to protect our State Programs.

Based on the committee's findings, the MTAC State Board of Directors has decided to eliminate Path B of the Certificate of Merit program. This was a difficult decision. It affects all who participate in the program.

The 2012 Theory Tests will not be sold at Convention but will be available for purchase by members through the MTAC website.

More information will be provided at the Certificate of Merit meetings at the MTAC Annual Convention. We look forward to seeing you all in San Diego soon.

Parent/Adult Student Consent Form and Waiver

Beginning in the 2012-2013 fiscal year, MTAC will require all parents to sign an online consent form and liability waiver for children. Adult students, 18 years and over, will need to sign the forms themselves. The form will be similar to those signed by parents when their children participate in youth sports, school music programs, and other extracurricular activities. This will involve some changes for teachers in the online registration process for State Programs next year. Training sessions will be provided for you or your designated Branch representative at the MTAC Convention to help facilitate this process.

- Represents Four Repertoire Categories: Baroque, Classical, Romantic & Impressionistic, and 20th and 21st Century (composers who have "come of age" in the 20th Century or were born after 1880)
- Offers greater choice and flexibility with the addition of new and additional varied and exciting repertoire
- Built upon the success of previous syllabi

NEW MTAC STRING SYLLABUS FOR 2013 EVALUATIONS

Special Convention Session

2:15 p.m. Saturday, June 30, 2012 - Town and Esquire Meeting Room

- Represents Four Repertoire Categories
- Addition of Theory, Ear Training and Sight-reading in Levels Preparatory through Level 3
- Technique is standardized all students in each Level play the same scales and arpeggios
- Double-stop etude requirement for Levels 6 and 7 has been removed
- Etudes are 1-1/2 to 2 minutes in length for Levels 4 through Advanced (10)
- Etudes/orchestral excerpts have been re-distributed into more appropriate levels.
- Repertoire is broader with a range of difficulty at each level. Some pieces are listed at multiple levels
- Students may only play pieces at or above their enrolled level (not below)
- Known out-of-print repertoire has been removed. Out-of-print pieces may still be played at CM evaluations but not as the syllabus piece

2012-2013 MEMBERSHIP RENEWAL REMINDER

Email letter to Branch Chairs from Madeline Miller and Judi Sands-Pertel, 5/24/12.



Dear Chairs,

The MTAC State Board and CM Council realize the elimination of Path B comes as a surprise to many teachers, especially the teachers who utilized the program as it was originally intended.

However, there are several reasons for which the program was eliminated in the best interests of the organization and all our members. Some examples are as follows:

- The number of participants in Path B has been declining over the last few years, with more teachers, parents, and students interested primarily in Path A.
- Parents did not understand the difference between Path A and Path B, which resulted in confusion.
- Some Branches used Path B to decrease the number of Path A students which caused unfairness across the state by not allowing the benefits of Path A to all students, such as Convention Recitals.
- Colleges and universities desire transparency about the achievements of students who participate in Certificate of Merit when listed on college applications, and the parallel existence of Path A and Path B reduced transparency.
- ➤ Outside organizations have attempted to replicate large portions of the CM program from previous Path B materials, in conflict with copyright and trademark laws.

Teachers can still effectively use the CM Curriculum and Materials for all their students and are free to set up their own in-studio evaluations using the CM Curriculum as a guide, but may not represent that the in-studio evaluation is a Certificate of Merit Evaluation or use the trademark name "Certificate of Merit" on any studio certificates or awards they provide to students.
